FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS MAX VISTA, WARRI ?

MAX VISTA, WARRI is an undeveloped parcel of land located at Egborode Community along Warri-Sapele road Okpe LGA, Delta State

Q2. WHO ARE THE OWNERS/DEVELOPERS OF MAX VISTA, WARRI?

A PWAN MAX, a Leading Real Estate Company with offices in Enugu State, Owerri Imo State, Awka Anambra State, Uyo, Akwa-Ibom State, Port Harcout, Rivers State, Asaba, Delta State & Lekki, Lagos State.

O3. WHAT TYPE OF TITLE DOES MAX VISTA, WARRI HAVE ON THE LAND?

A REGISTERED SURVEY & DEED OF ASSIGNMENT

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government interests or adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?

Q16. WHAT HAPPENS IF I CANNOT CONTINUE WITH MY PAYMENT? CAN I REQUEST FOR A REFUND?

A Yes, you can apply for refund only if you have NOT been allocated your plot(s). In the event of a Refund, you are required to give the Company Ninety (90) days' notice to process your refund request and a further Sixty (60) days if the process isn't completed after the first 90 days. The refund shall be processed and paid less 40% (Administrative Fee and Others).
