Q1. WHERE IS EKAABO (THE CROWN JEWEL)?

EKAABO (THE CROWN JEWEL) is an undeveloped parcel of land in Awodikura Ode-Omi

Q2. WHO ARE THE OWNERS/DEVELOPERS OF EKAABO (THE CROWN JEWEL)?

A PWAN MAX, a Leading Real Estate Company with offices in Enugu State, Owerri Imo State, Awka Anambra State, Uyo, Akwa - Ibom State, Port Harcout, Rivers State, Asaba, Delta State & Lekki, Lagos State.

Q3. WHAT TYPE OF TITLE DOES EKAABO (THE CROWN JEWEL) HAVE ON THE LAND?

A Registered Survey and Deed of Assignment
