Q1. WHERE IS MAX PALACE AFAHA OBONG ABAK?

MAX PALACE, AFAHA OBONG ABAK is an underdeveloped parcel of land located at Ikot Udo Urom, Afaha Obong, O fflkot Ekpene Road, Abak, Abak Lga, Akwa Ibom State.

Q2. WHO ARE THE OWNERS/DEVELOPERS OF MAX PALACE, AFAHA OBONG ABAK?

A PWAN MAX, a Leading Real Estate Company with offices in Ibeju Lekki Lagos State, Abak, Uyo, Akwa-Ibom State, PortHarcout, Rivers State, Asaba, Delta State & Owerri, Imo State

Q3. WHAT TYPE OF TITLE DOES MAX PALACE, AFAHA OBONG ABAK HAVE ON THE LAND?

A Registered Survey & Deed Of Assignment

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government interests or adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?

- A Outright payment of N2,200,000 per 464 sqm only

Q8. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND?

Q16. WHAT HAPPENS IF I CANNOT CONTINUE WITH MY PAYMENT? CAN I REQUEST FOR A REFUND?

Yes , you can apply for refund only if you have NOT been allocated your plot(s). In the event of a Refund ,you are required to give the Company Ninety (90) days' notice to process your refund request and a further Sixty (60) days if the process isn't completed after the first 90 days. The refund shall be processed and paid less 40% (Administrative Fee and Others).
