#### FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS OF PURCHASE

- Q1. WHERE IS MAX GARDEN CITY ABEOKUTA?
- A MAX GARDEN CITY ABEOKUTA is an undeveloped parcel of land Being, Situate, lying at AKINOSI AND KUOLE ORILE OLOWU COMMUNITY, AIYETORO ABEOKUTA,

#### Q2. WHY SHOULD I BUY MAX GARDEN CITY ABEOKUTA?

A MAX GARDEN CITY ABEOKUTA enjoys proximity to major commercial investment landmarks guaranteeing hyper return on investment

#### Q3 WHO ARE THE OWNERS/DEVELOPERS OF MAX GARDEN CITY ABEOKUTA ?

#### Q4. WHAT TYPE OF TITLE DOES MAX GARDEN CITY ABEOKUTA HAVE ON THE LAND?

A Registered Survey and Deed of Assignment

#### Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government acquisition or interests and/or adverse claims.

#### **Q6. WHAT IS THE PAYMENT STRUCTURE?**

A Outright payment (0-3months) of N800,000 only per 600sqm with a minimum deposit of N500,000 per plot N.B- The Company reserves the right to repudiate, void or defer/transfer processing of transactions that violate the initial deposit threshold or payments that are made after the official announcement of close of sales. Payment validates subscription even if date on subscription form is earlier than the date of payment.

B 12 Months Instalment Payment can be arranged and attracts additional charges of 10%.

N.B: Non-Payment of the monthly instalments as at when due shall be treated as a fundamental breach of the contract which shall result in termination or revocation of the contract/ OR attract default charge of 10% of the month payment. The Company shall reserve the right to review number of plots

purchased in the event of payment default after the company having sent at least 2 consecutive notices to subscriber on payment default.

#### Q7. WHAT IS THE SIZE OF THE PLOT?

A 600 SQM

#### Q8. IS THE ROAD TO THE ESTATE MOTORABLE?

A Yes. The road to the estate is motorable and is maintained by PWAN.

#### Q9. WHAT OTHER PAYMENTS DO I MAKE APART FROM THE PAYMENT FOR THE LAND ?

- A Deed of Assignment : N100,000 only per plot (Subject to review upwards)
- B Survey Fee : N150,000 only per plot (Survey Plan with Company's name attracts extra charges) (Subject to review upwards)

#### Q10. WHEN DO I MAKE THE OTHER PAYMENTS?

#### Q14. IS THERE ANY RESTRICTION REGARDING THE TYPE OF BUILDING I CAN CONSTRUCT IN THE ESTATE?
