FREQUENTLY ASKED QUESTIONS/ TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS MAX HEIGHTS?

A MAX HEIGHTS is an undeveloped parcel of land situated at Avu-Oforola, off Port Harcourt road Owerri, Imo State.

Q2. WHY SHOULD I BUY MAX HEIGHTS?

A MAX HEIGHTS enjoys proximity to major commercial investment landmarks guaranteeing hyper return on investment

Q3 WHO ARE THE OWNERS/DEVELOPERS OF MAX HEIGHTS?
