# FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

## Q1. WHERE IS ILE OBA LOCATED

A ILE OBA is an undeveloped parcel of land situated at Awodikura Ode-Omi, Ibeju – Lekki, Lagos. Applicants or their representatives are advised to inspect the site

as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

## Q2. WHY SHOULD I BUY ILE OBA?

A ILE OBA enjoys proximity to major commercial investment landmarks, guaranteeing tremendous return on investment.

# Q3 WHO ARE THE OWNERS/DEVELOPERS OF ILE OBA?

A ILE OBA is an exclusive estate developed by PWAN MAX PROPERTY AND BUSINESS SOLUTIONS LTD.

## Q4. WHAT TYPE OF TITLE DOES ILE OBA HAVE?

A Survey and Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

## Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

The land is free from every known government acquisition or interests, and adverse claims.

#### O6. WHAT IS THE PAYMENT PLAN?

- A Outright payment of N1,500,000 only per 600 sqm, within the first six (6) months; and a minimum deposit of N500,000 per plot.

  N.B. The company reserves the right to repudiate, void or defer/transfer processing of transactions that violate the initial deposit threshold or payments that are made after the official announcement of close of sales. Payment validates subscription even if date on subscription form is earlier than the date of payment.
- B Twelve (12) months instalment payment can be arranged and attracts additional charges of 10% of monthly payment.

  N.B: Non-payment of the monthly instalments as at when due shall be treated as a fundamental breach of the contract, which shall result in termination or revocation of the contract/OR attract default charge of 10% of monthly payment. The company shall reserve the right to review number of plots purchased in the event of payment default after the company has sent two consecutive notices to subscriber.

# Q9. WHAT OTHER PAYMENTS DO I MAKE BESIDES PAYMENT FOR THE LAND?

C Plot Demarcation Fee: N50,000 only per plot (subject to review upwards)
