#### Q1. WHERE IS MAX GARDEN CITY AKURE LOCATED?

A Max Garden City Akure is a prime piece of land situated at Akponmu Isinkan via Ondo- Akure Expressway, Ondo state. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.
