FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS MAX VISTA CALABAR LOCATED?

A Max Vista Calabar is a prime piece of land situated and lying at Udidem Usang Iso Boulevard Calabar Municipality, Cross River State. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

Q2. WHY SHOULD I BUY MAX VISTA CALABAR?

A Max Vista Calabar enjoys proximity to major commercial investments and landmarks guaranteeing high return on Investment.

Q3 WHO ARE THE OWNERS/DEVELOPERS OF MAX VISTA CALABAR?

A Max Vista Calabar is owned and developed by PWAN MAX PROPERTY AND BUSINESS SOLUTIONS LTD.

Q4. WHAT TYPE OF TITLE DOES MAX VISTA CALABAR HAVE?

A Survey and Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government acquisition or interests, and adverse claims.

Q6. WHAT IS THE PAYMENT PLAN?
