#### FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

### Q1. WHERE IS SALVATION GARDENS ASABA LOCATED?

A Salvation Gardens Asaba is a prime piece of land situated at Achala Ibusa behind Jeff (Bovans) Filling Station, Asaba, Delta State. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

#### Q2. WHY SHOULD I BUY SALVATION GARDENS ASABA?

A Salvation Gardens enjoys proximity to major commercial investments and landmarks guaranteeing high return on Investment.

#### Q3 WHO ARE THE OWNERS/DEVELOPERS OF SALVATION GARDENS ASABA?

# Q4. WHAT TYPE OF TITLE DOES SALVATION GARDENS HAVE?

A Survey and Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

#### Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?
