FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS MAX GARDEN CITY, ILORIN LOCATED?

A Max Garden City, Ilorin is a prime piece of land situated at Oke oyi, Jebba Road, Ilorin East LGA, Ilorin, Kwara state. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspectons hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

Q2. WHY SHOULD I BUY MAX GARDEN CITY, ILORIN?

A Max Garden City, llorin enjoys proximity to major commercial investments and landmarks such as: Kwara state Polytechnic, Bulletin Quarry site and Local Government Secretariat. Guaranteeing high return on Investment.

A Deed of Assignment & Survey. The company has the long-term responsibility to ensure/facilitate further perfecting of the estate's the subject to subscriber's payment of the perfection fees to be determined and communicated at a future date.

Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government acquisitionor interests , and adverse claims.

Q6. WHAT IS THE PAYMENT PLAN?
