## Q1. WHERE IS MAX COURT, IBALOJA LOCATED?

A MAX COURT, IBALOJA is a prime piece of land situated and Lying Ibaloja, Ibeju Lekki, Lagos. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

#### Q2. WHY SHOULD I BUY MAX COURT, IBALOJA?

## Q4. WHAT TYPE OF TITLE DOES MAX COURT, IBALOJA HAVE?

A Survey and Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

## Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government acquisition or interests, and adverse claims.

## Q6. WHAT IS THE PAYMENT PLAN?

A. Outright payment (0-6months) of N3,500,000 only per 550sqm with a minimum deposit of N500,000 per plot

Payment validates subscription even if date on subscription form is earlier than the date of payment.

B 12 months instalment payment can be arranged; and attracts additional charges of 10%.

Non-payment of the monthly instalments as at when due shall be treated as a fundamental breach of the contract, which shall result in termination or revocation of the contract; OR attract default charge of 10% of the monthly payment. ## Q9. WHAT OTHER PAYMENTS DO I MAKE ASIDE THE PAYMENT FOR THE LAND?

- C Plot Demarcation Fee: N50, 000 only per plot (subject to review upwards)

# Q10. WHEN DO I MAKE THE OTHER PAYMENTS?
