## Q1. WHERE IS MAX VISTA IBADAN LOCATED?

A Max Vista Ibadan is a prime piece of land situated at Akufo Town, Ido LGA, Ibadan Oyo state. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections is hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

## Q2. WHY SHOULD I BUY MAX VISTA IBADAN?
