FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS MAX BAY, ASABA LOCATED?

A Max Bay, Asaba is a prime piece of land situated and lying behind Delta State Polytechnic, Ogwasi uku Asaba, Delta State. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/iss ues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

Q2. WHY SHOULD I BUY MAX BAY ASABA?

Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government acquisiton or interests, and adverse claims.

Q6. WHAT IS THE PAYMENT PLAN?

A Outright payment of 1,500,000 only per 464sqm within the first three (3) months; with a minimum deposit of N500,000 per plot.

Q12. WHAT DO I GET AFTER COMPLETING PAYMENT FOR THE LAND?

The company reserves the right to allocate subscribers to a new and nearby scheme/phase of the estate.

Q13. CAN I START CONSTRUCTION OR BUILDING ON THE LAND IMMEDIATELY?

A You can start building on the land afer physical allocaton provided development fee has been paid. Fencing & Gatehouse would be constructed within the first year of introducing the estate, while other infrastructure will commence from the second year with regard to the general level of development in the area, satsfactory evidence of possession of plots by subscriber and payment of development fee.

Q15. IS THERE ANY RESTRICTION REGARDING THE TYPE OF BUILDING I CAN CONSTRUCT IN THE ESTATE?

A Yes. The estate layout is in sections, and you are expected to build in conformity with the required setback, building control and designated plan for that section (commercial or residential) i.e., bungalow, block of flats or detached houses (duplex). Q16. CAN I RE-SELL MY PLOT/PROPERTY?

Q18 WHAT HAPPENS IF I CANNOT CONTINUE WITH MY PAYMENT? CAN I REQUEST A REFUND?
