FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

Q1. WHERE IS MAX HEIGHTS MOWE LOCATED?

A Max Heights Mowe is a prime piece of land situated at Abule potoki, Obafemi owode, Mowe. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

Q2. WHY SHOULD I BUY MAX HEIGHTS MOWE?

A Max Heights Mowe enjoys proximity to major commercial investments and landmarks such as: New Hope Company, Apple and Pears LTD and International Beweries. guaranteeing high return on Investment

Q3 WHO ARE THE OWNERS/DEVELOPERS OF MAX HEIGHTS MOWE?

A Max Heights Mowe is owned and developed by PWAN MAX PROPERTY AND BUSINESS SOLUTIONS LTD.

Q4. WHAT TYPE OF TITLE DOES MAX HEIGHTS MOWE HAVE?

A Survey & Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?
