Q1. WHERE IS THE PERIDOT, OKPANAM ASABA LOCATED?

A The Peridot, Okpanam Asaba is a prime piece of land situated Okpanam, in Asaba/Benin expressway,Behind Wich-tech roofing Company, Okpanam Delta State. Applicants or their representaties are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

Q13. CAN I START CONSTRUCTION OR BUILDING ON THE LAND IMMEDIATELY?

A You can start building on the land afer physical allocaton provided development fee has been paid. Fencing & Gatehouse would be constructed within the first year of introducing the estate, while other infrastructure will commence from the second year with regard to the general level of development in the area, satsfactory evidence of possession of plots by subscriber and payment of development fee.
