# FREQUENTLY ASKED QUESTIONS/TERMS AND CONDITIONS OF PURCHASE

# Q1. WHERE IS LA LAGUNE ESTATE LOCATED?

A LA LAGUNE ESTATE is a prime piece of land situated and Lying at Akodo road, Ibeju Lekki, Lagos. Applicants or their representatives are advised to inspect the site as the company shall not be held liable for claims/issues arising from client's failure to inspect the said property before purchase. Free inspections hold Mondays to Saturdays, from 10 a.m., and Sundays on special arrangement.

## Q2. WHY SHOULD I BUY LA LAGUNE ESTATE?

LA LAGUNE ESTATE enjoys proximity to major commercial investments and landmarks Such As: La Campaign Tropicana, Dangote Refinery,

Lekki Sea Port, Free Zone guaranteeing high return on Investment.

## Q3 WHO ARE THE OWNERS/DEVELOPERS OF LA LAGUNE ESTATE?

A LA LAGUNE ESTATE is owned and developed by PWAN MAX PROPERTY AND BUSINESS SOLUTIONS LTD.

#### Q4. WHAT TYPE OF TITLE DOES LA LAGUNE ESTATE HAVE?

A Survey and Deed of Assignment. The company has the long-term responsibility to ensure/facilitate further perfection of the estate's title subject to subscriber's payment of title perfection fees to be determined and communicated at a future date.

#### Q5. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A The land is free from every known government acquisition or interests, and adverse claims.

#### Q6. WHAT IS THE PAYMENT PLAN?

A Outright payment of N30,000,000 only per 600sqm within the first three (3) months; with a minimum deposit of N5,000,000 per plot. N.B The Company reserves the right to repudiate, void or defer/transfer processing of transactions that violate the initial deposit threshold or payments that are made after the official announcement of close of sales. Payment validates subscription even if date on subscription form is earlier than the date of payment.

### B 12 months instalment payment can be arranged; and attracts additional charges of 20%.

# Q9. WHAT OTHER PAYMENTS DO I MAKE ASIDE THE PAYMENT FOR THE LAND?

- A Deed of Assignment: N200, 000 only per plot (subject to review upwards)
- B Survey Fee: N200, 000 only per plot (Survey Plan with company name attracts extra charges, subject to review upwards)
- C Plot Demarcation Fee: N100, 000 only per plot (subject to review upwards)
- D Development Levy: N5,000,000 only per plot (Subjected to review upwards) Developmental fee cover the following (1) Perimeter fencing (2) Gate house (3) Earth Road
  - ii. Infrastructure Fee: To be determine later (Drainage construction; electrification; good road network, security and special amenities).
